Minutes Executive Session – November 21, 2023

The Board entered executive session at 7:59 p.m.

I. Cheray Reid Account

Mbr. Richards that the committee recommended the full discharge of the outstanding balance for Cheray Reid of \$2,951.64 in consideration of mitigating circumstances, specifically the co-signer's claim that the loan had been paid and the board's inability to validate the records, and the age of the loan.

MOTION: Mbr. Richards moved to discharge in full the outstanding balance for Cheray Reid.

The motion failed for lack of a second.

MOTION: Mbr. Sekou moved that the standard approach be used for

loans where there is a dispute and waive 50% interest.

SECOND: Mbr. Joseph

Objection: Mbr. Richards who said that option had been considered by the committee and rejected since neither side can provide documentation.

Voting was as follows:

The motion failed.

MOTION: Vice-Chair Cassius moved for the borrower to repay the principal only of \$1,202.52 within 6 months and if payment is not made then the board will proceed with corrective action.

Objection: Mbr. Gomez (before timeline and corrective action added)

III. Laurie Ryan Ruznack Account

The committee was asked to verify the bankruptcy notice for Ms. Ruznack before acting on the balance of \$4,335.30.

MOTION: Mbr. Richards moved to charge off the balance as part of the bankruptcy proceedings.

SECOND: Mbr. Joseph

Objection: Mbr. Gomez said the bankruptcy report should make the decision whether to discharge and the board should check with the court.

Voting was as follows:

Yea (2) –T. Joseph and S. Richards Nay (4) – k. Callwood, J. Gomez, E. Perez-Cassius and N. Sekou Not Voting (1) – W. Hendricks Excused (1) – A. Lockhart

The motion failed.

IV. Discussion of COVID Scholarship

Mbr. Sekou referenced the motion made in May and confusion whether the low GPA accommodation also applied to the COVID scholarship. She said the Board shouldn't be returning funds to the federal government and students with low GPA's should be eligible. Mbr. Gomez said the Board would need to go back to OMB if there were changes and get consent.

MOTION: Mbr. Sekou moved that students with low GPA's also receive the COVID scholarship if they filled out the application.

SECOND: Mbr. Joseph
