**VIRGIN ISLANDS BOARD OF EDUCATION
ANNOUNCES A SPECIAL BOARD MEETING**

The 21st elected Virgin Islands Board of Education (VIBE) will conduct a Special Board meeting on Saturday, May 18, 2024. The purpose of the meeting is to review applications and make selections for the 2024–2025 Special Legislative Grants and Territorial Scholarship Fund Program award period and approve candidates for certification. The meeting will begin at 11:30 a.m. via Microsoft Teams. The VIBE may go into executive session during the meeting to discuss certain matters as permitted or required by Virgin Islands law.

Due to limited capacity, advance registration (no later than three days prior to the meeting) and completion of a self-assessment health checklist are required to attend board meetings in-person. Meeting registrants are reminded that all persons are required to register on their own behalf. After registering, individuals will receive a confirmation email containing information about attending the meeting. Attendance will be immediately denied for refusal to complete the self-assessment or if an answer to any question is YES, regardless of vaccination status. Visitors must wear a mask entirely over the nose and mouth during in-person board meetings and in publicly accessible areas within the VIBE's facilities.
